GENERAL REGULATIONS

AC. LIABILITIES (cont'd)

The Company is not liable for any defacement of or damage to the premise of a customer resulting from the attachment of the Company's instruments, apparatus and associated wiring on such premises or by the installation or removal thereof, when such defacement or damage is not the result of negligence of the Company.

2. Of the Customer

The customer indemnifies and save the Company harmless from any and all claims (including any expense in connection with, defending against such claims); for infringement of patents arising from combining with, or using in connection with, facilities of the Company, apparatus or systems of the customer; arising out of any customer-provided facilities which are interconnected with the Company's facilities; or arising out of any act or omission of the customer in connection with facilities provided by the customer or by the Company.

AD. STATE TAX ADJUSTMENT SURCHARGE

1. In addition to the charges provided in this tariff and other state toll and access tariffs in which this company concurs, a surcharge, as shown below, will apply to all intrastate charges for service on or after September 1, 2010, except on calls from pay telephones. (C)

2. The above charges will be recomputed, using the same elements prescribed by the Commission:
